खनिजों पर अतिरिक्त कर...

विधेयक में कहा गया है, हालांकि, ऐसे लागू होने से पहले खनिज अधिकारों या खनिज-युक्त भूमि पर लगाया गया कोई कर, उपकर या अन्य शुल्क, जो पहले ही राज्य सरकार के पास जमा किया जा चुका है या उसके द्वारा वसूल किया जा चुका है, उसे वापस नहीं किया जायेगा। पर जिन्होंने सेस या कर जमा ही नहीं किया है तो उन्हें आगे भी जमा नहीं करना होगा।

सरकार ने बिल को आर्थिक विकास से जोड़ा : जी किसान रेड्डी ने कहा कि संशोधन का उद्देश्य खनिज क्षेत्र में वित्तीय व्यवस्था को स्थिर, स्पष्ट और अनुमान योग्य बनाना है। उनके मुताबिक इससे राष्ट्रीय आर्थिक विकास को बढ़ावा मिलेगा और आत्मनिर्भर भारत तथा 2047 तक विकसित भारत के लक्ष्य में मदद मिलेगी। उन्होंने कहा कि खनिजों पर अलग-अलग क्षेत्रों में असमान कर व्यवस्था सार्वजनिक हित को प्रभावित करती है। अधिक टैक्स और शुल्क से स्थानीय आपूर्ति व्यवस्था प्रभावित होने, बाजार के विकास में कमी आने और परिवहन लागत बढ़ने की स्थिति पैदा हो सकती है। केंद्रीय मंत्री ने कहा कि खनिजों पर असमान कर व्यवस्था से घरेलू आपूर्ति महंगी हो सकती है और

पर्याप्त स्थानीय संसाधन उपलब्ध होने के बावजूद खनिजों के आयात का जोखिम बढ़ सकता है। इसका असर आम नागरिक के जीवन-यापन की लागत पर पड़ सकता है।

राहत : पलामू और गढ़वा छोड़...

पलामू प्रमंडल में यह आंकड़ा सबसे कम करीब 26.81% ही है। राज्य के सभी जिलों में देवघर (92.95%) और दुमका (83.73%) जैसे जिलों में धान का कवरेज काफी बेहतर है।

जुलाई में पलामू में हुई मात्र 69.2 मिमी बारिश : जुलाई 2026 के दौरान पलामू जिले में 344.7 मिमी की सामान्य वर्षा के मुकाबले केवल 69.2 मिमी वर्षा हुई। यह सामान्य का मात्र 20.08 प्रतिशत है। अगस्त महीने की शुरुआत (एक से 12 अगस्त तक) में भी पलामू की स्थिति खराब रही। यहां राज्य की औसत वर्षा 81.4 मिमी रही है। वहीं पलामू में इस दौरान केवल 12.3 मिमी बारिश दर्ज की गई है। आंकड़ों के अनुसार, पलामू में धान की सीधी बुआई का क्षेत्र शून्य है। इसका मतलब है कि यहां खेती पूरी तरह से रोपाई पर निर्भर है, जिसके लिए पर्याप्त पानी की आवश्यकता होती है।
